




ARCSOPT Purpose

The philosophy is built upon promoting consistency of approach and mutual benefit for all with the four (4) key pillars of:



- Big growth in the associate membership (starting of with 3 organisations)






Membership Update

Technical Guideline Marine Pilot Transfer Arrangements

A revision is underway. This will include number of new items such as securing ropes, locations etc. The revised version will be circulated to the committee for review.

Technical Guideline Mooring Guidance Document

Technical Proposal Standardised Acceptance (Pre-Arrival) Questionnaire & Hosting Platforms

Goal to facilitate a standardised approach to pre-arrival questionnaires in a format that can be used by any platform.

Technical Proposal Engine Power Limitations

Guidance regarding decisions and actions to be taken when the vessel is equipped with an engine power-limiting arrangement to comply with the EEXI requirements, along with a decision support assessment to evaluate the need to override such systems
