

MER Vetting Superintendent Comments:

The vessel did undergo a BVIQ inspection on the 12th of January 2024. The vessel had previously undertaken five (5) inspections over a four (4) year period.

There had been an improvement between the 2023 and 2024 inspections. There were a number of minor findings which were closed out in line with MER Vet guidelines.

The vessel's benchmarking analysis indicated that the finding average was above the peer group however the inspection finding when compared to the peer group were minor in nature. The vessel's inspection findings over the fouryear period were minor.

The Port State records were reviewed and averaged less than two (2) findings per inspection.

The BVIQ report dated 12th of January 2024 indicated that the vessel fabric condition was fair to good. There were no MLC or crew issues noted.
